2. Commissioner and Staff Member Introductions

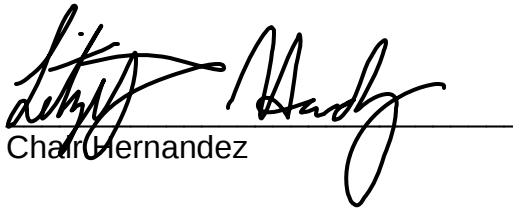
Commission Members and staff members introduced themselves.
