2. BOARDS, COMMISSIONS, AND COMMITTEES APPLICATIONS FOR APPOINTMENT

The Council Subcommittee on Boards, Commissions, and Committees recommended appointments for the following Boards and Commissions.

a. AUDIT COMMITTEE

Council Subcommittee recommended the reappointment of Norma Pacheco for an additional term.

b. CORRECTION OFFICERS RETIREMENT PENSION BOARD

Council Subcommittee recommended the reappointment of Maria Aguilar, the appointment of Von Ryan Burns to one of the available seats, and to continue recruitment for the remaining seat.

c. MUNICIPAL ART COMMITTEE

Council Subcommittee recommended the reappointment of Gaven Mejia, Deanna Zapata, and Sara Ivey. The Subcommittee also recommended the appointment of Shqipe Hyseni to a partial term and to continue recruitment for the special qualification seat.

d. NEIGHBORHOOD AND FAMILY SERVICES COMMISSION

Council Subcommittee recommended the reappointment of Natosha Edmonds and Louis Matamoros. The Subcommittee further recommended that Louis Matamoros be moved from alternate to regular member and that Kim Lewis be appointed to the alternate seat.

Council Subcommittee recommended the reappointment of Paul Lemmon for an additional term.

g. PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM (PSPRS) BOARD – POLICE

Council Subcommittee recommended the reappointment of Paul Lemmon for an additional term.

h. RISK MANAGEMENT & WORKER'S COMPENSATION BOARD

Council Subcommittee recommended that recruitment continues for the two open seats.

i. SUSTAINABILITY COMMISSION

Council Subcommittee recommended the reappointment of Daniel Smith-Castillo and Diana Estrada. The Subcommittee further recommended that Amanda Duncan-Billiman be moved from alternate to regular member and that Von Ryan Burns be appointed as an alternate member.
